NOTICE OF APPLICABLE BORDER FEES (RECIPROCITY MEASURES WITH DRC) IN ANGOLA

This notice serves to inform all members of the Cross Border Road Transport - Regulators Forum regarding the applicable fees charged by Angolan institutions at border posts in Angola, specifically for traffic entering Angola from the DRC (Democratic Republic of Congo) or transit destined for the DRC. These fees are implemented as part of reciprocity measures. These fees have been in force since July 1, 2025.

The aforementioned fees are in force under the terms of Joint Executive Decree No. 6/25 of April 9.

In addition to this additional fee, the operator must pay for the following services:

- 1- Cross-Border Road Transport Permit for Goods for Foreign Operators 1,500.00 USD equivalent to KZ 1,366,500.00.
- 2- Authorization for Cross-Border Transport in a Heavy Vehicle for a Foreign Operator 1,500.00 USD equivalent to KZ 1,366,500.00.
- 3- Road Usage Fee for a distance over 100 KM Heavy 1,000.00 USD equivalent in KZ 911,000.00.
