NOTICE OF REVIEWED TOLL FEES PAYABLE UPON ENTRY INTO ANGOLA

This serve to notify all members of the Cross Border Road Transport - Regulators Forum regarding the applicable fees charged by Angolan institutions upon entry into Angola, within the scope of cross-border road transport activities. These fees shall be enforced from November 20, 2025, specifically at the Santa Clara border between Angola and Namibia.

The aforementioned fees are in force under the terms of Presidential Decree No. 1/24 of January 3, read with the Executive Decree No. 1/24 of March 20.
